

## **Opt-Out from Profiling; Consumer Rights Related to Profiling**

If you are a resident of California, Colorado, Connecticut, Delaware, Indiana, Iowa, Kentucky, Maryland, Minnesota, Montana, Nebraska, New Hampshire, New Jersey, Oregon, Rhode Island, Tennessee, Texas, Utah or Virginia, you may:

- Opt-out from our use of your personal information to create a profile, and/or to evaluate, analyze or predict personal aspects related to you.
- Receive notice if we have made any profiling decisions that have produced legal effects, or similarly significant effects, that concern you.
- Obtain information regarding the reason that the profiling activity resulted in the applicable decision.
- Obtain information regarding what actions you can take, if any, that would result in a different profiling decision in the future.
- Obtain the specific pieces of your personal information that were used in the profiling process and, if the profiling was based on inaccurate data, you may correct same.
